SUBJECT: Status of Planning Efforts for State Vehicular Recreation Areas

Summary

Several planning efforts are underway within State Vehicular Recreation Areas (SVRAs). Carnegie SVRA, Ocotillo Wells SVRA, and Hungry Valley SVRA are in the process of updating their park general plans. There are also several OHV-related studies in the process, including an economic and demographic study and a study to expand OHV recreation in the State. This report describes each plan's purpose, process, and current milestones.

Discussion

Following is a summary of recent SVRA/OHV general plan developments.

Carnegie SVRA General Plan Update:

PUBLIC REVIEW PERIOD: The Preliminary General Plan and Draft EIR are being circulated for public review and comment for 45 days, beginning January 15, 2024. Written comments germane to the environmental review will be considered and responded to in the Final EIR. Written comments should be submitted with a contact name and mailing address for the public record. Your views and comments on this project are welcomed. This proposed General Plan Update and EIR are limited to the 1,575-acre original Carnegie SVRA and exclude the Expansion Area, which was the subject of a lawsuit. The classification of and planning for the Expansion Area will be addressed in the future under a separate planning effort. Alameda-Tesla Classification and General Plan

More than two decades ago, State Parks acquired the Alameda-Tesla Property with the intent of expanding the adjacent Carnegie State Vehicular Recreation Area. After challenges to this plan in 2021, SB 155 (PRC sec. 5090.42) authorized planning work to determine the best use of the land and specified that the property shall not be designated as a state vehicular recreation area or be considered for any future expansion of off-highway vehicle recreation.

The Alameda Tesla Classification and General Plan Project includes work to classify and name the property as a new park within the State Parks system, followed by development of a General Plan and environmental impact report for the new park. Together, these two planning efforts will determine the best use of the land and guide future management and use of the site.

The Alameda-Tesla Classification and General Plan Project has two phases: I) Park Classification and Naming and II) General Plan and Environmental Impact Report (EIR) development. During both phases, the public will have multiple opportunities to share input that will inform project outcomes, as shown on the [Participate](#) page of the project webpage (www.alamedateslaplan.com). Most recently, the project team held an in-person public meeting on November 14 and a virtual meeting on November 28, 2023.

Hungry Valley SVRA General Plan Update:

On November 2, 2023, State Parks prepared a Notice of Preparation (NOP) pursuant to Section 15082 of the California Environmental Quality Act (CEQA) Guidelines. The NOP informs agencies and the public that an EIR is being prepared to address potential impacts resulting from implementing the proposed Hungry Valley SVRA General Plan Update. Publication of the NOP provides an opportunity for public comment on the environmental impacts to be addressed in the EIR. The full NOP document and additional information about the Hungry Valley SVRA General Plan Update process are available on the project website (www.planhungryvalley.com).

The Planning Team held a virtual public Environmental Scoping meeting using the Zoom platform on November 16, 2023, from 6:00 to 7:30 p.m., where the public could ask questions and interact with the planning team concerning the NOP. The public comment period was from 11/02/2023 – 12/01/2023.

The Hungry Valley SVRA General Plan has a project website at www.PlanHungryValley.com to facilitate public involvement and communication. Interested parties should visit the project website and register to receive email

notifications regarding project progress. The planning team is preparing the administrative draft general plan and EIR for public review in Spring/Summer 2024.

Ocotillo Wells SVRA Plan:

Ocotillo Wells SVRA and the Bureau of Land Management (BLM) El Centro Field Office are developing a joint general plan for the Ocotillo Wells SVRA/Ocotillo Wells Special Recreation Management Area. This joint planning document will meet the State Park's General Plan and BLM land management requirements for a California State Park unit General Plan, a BLM Recreation Area Management Plan, and a California Desert Conservation Area Land Use Plan Amendment. The latter two plans are federal planning documents. The combined Environmental Impact Report/Environmental Impact Statement (EIR/EIS) will meet the requirements of both the California Environmental Quality Act (CEQA) and the National Environmental Policy Act (NEPA). The core team working on the joint plan comprises staff from State Parks, BLM, and AECOM (consultants). [This effort started in 2019, paused due to lack of federal effort at that time and has been restarted.](#)

Prairie City SVRA Road and Trail Management Plan

The purpose of the Road and Trail Management Plan (RTMP) is to provide specific guidance and direction for implementing the goals and guidelines of the 2016 Prairie City SVRA General Plan. The RTMP is a comprehensive planning document that examines the SVRA's existing system of roads and provides specific direction for their long-term construction, maintenance, and management. It considers current and potential public use, park operations, and the protection and enhancement of cultural and natural resources to ensure recreational trail opportunities are available at their fullest potential. Comprehensive trail planning also considers regional recreational opportunities and connectivity and includes extensive public outreach and input into designing new trails and experiences. The planning process began in Spring 2023 and will continue through Fall 2024.

OHV/OSV Economic Impact Study:

Field work for the survey (one research component of the OHV/OSV Economic Impact Study) has been ongoing at State Park, US Forest Services, and BLM OHV areas throughout the state. The survey and all outreach materials (email, posters, postcards) are in English and Spanish. Data collection for the special events version of the survey began in 2022 and included Hangtown in June 2023. Secondary data analysis includes DMV registration data to help correlate data collected in the survey. A draft report is expected in Spring 2024.

OHV Access Initiative

In September 2021, [Senate Bill 155](#) (Ch. 258, Statutes of 2021) amended Public Resources Code (PRC) Section (§) [5090.42](#), directing the California Department of Parks and Recreation, popularly known as State Parks, to explore the acquisition and development of properties and opportunities to expand off-highway vehicle (OHV) recreation in new and existing facilities. This bill also recommended prioritizing opportunities that serve large urban areas such as the Bay Area and Central Valley and offer potential recreational opportunities for OHV recreation and motorized access to nonmotorized recreation. State Parks have many options for expanding OHV recreation throughout the state – through acquisition, lease, land swap, partnership, donation, transfer, legislation, and other means as established in PRC §5005, 5006, et seq.

The first step in this process – where we are now -- is to gather information through public outreach and research. Then, State Parks will prepare a preliminary report, feasibility study, and the OHV Recreation Action Plan. Once these steps are complete, the department will work on strategies to implement the recommendations.

State Parks has held six public meetings for the OHV Access Project and a workshop with the OHMVR Commission since November 2022. The last workshop in this series was held virtually on December 6, 2023. Additional stakeholder meetings and public workshops will be scheduled in 2024 as State Parks prepares the preliminary report.

The public may take the online survey to provide input if they could not attend the in-person workshops. The survey will remain open until February 2024.
